# **Local Planning Services Grant**

Chairman Honig commented there were a lot of definitions updated; he would like to get some feed back but he understands there is a lot going on.

#### Park Grant

Chairman Honig asked about the survey that came out after the packets went out.

Mike Vreeland, Engineer commented our survey group got out there and did the field work so we finished the survey. Ms. Hough handed out copies for the survey. Mr. Vreeland commented we didn't survey every inch of the property but we surveyed behind the fire house, basketball court and that recreation area and we also surveyed the area around the baseball field where the trail [walking path] would go. Mr. Vreeland commented the field work has been done so probably the next step is to try and put together budget numbers for the things we were considering, redoing the basketball courts.

Mayor Hutnick asked he wanted to know if we redo the basketball courts can we add a pickleball court.

Chairman Honig commented he is hoping we can start moving forward on this but a lot of this falls on the Council at this point.

Mr. Fitzgibbons explained an article in the Star Ledger regarding funds being distributed from the Legislation recently passed grants and ad for all the States.

Mr. Vreeland explained there is a lot of administrative work that goes into a grant.

# **Zoning Map & zoning ordinance review**

Chairman Honig commented we have been discussing the zoning map and zoning ordinance review; in November we talked about possibly setting aside funds to update the zoning map. So, we do have the funds available for use; he knows there is a lot of leg work to go through that. Mayor Hutnick commented they are putting a plan together to come up Main Street first then going to follow hitting everything they can aerial and then they are going to come back and do underground.

Mr. Kibilis asked about isolated places like Arch Street.

Mayor Hutnick commented it is all aerial; they are doing a wire wrap they called it; basically, they are going to run new lines but wire wrap around the existing lines. It isn't just businesses it is going right to your house. They are going to give us a heads up when their start date is going to be and then it is four to six weeks.

Mr. Fierro asked if it was Planet Network. Mayor Hutnick commented this was Altice.
