Attorney Thomas called for a motion for Chairman of the Land Use Board for 2014. A motion to appoint Robert Armstrong as Chairman was made by John Fierro, second by Patricia Dolan with Ciasullo, McGuire, Fitzgibbons, Honig, Telischak and Horuzy also in favor.

A motion to appoint Patrick Fitzgibbons as Vice Chairman was made by John Fierro, second by Elliott Honig with Armstrong, Ciasullo, Dolan, McGuire, Telischak and Horuzy also in favor.

A motion to appoint Roger Thomas of Dolan and Dolan, P.A. was made by Patrick Fitzgibbons, second by Patricia Dolan with Armstrong, Ciasullo, Fierro, Honig, McGuire, Horuzy and Telischak also in favor.

A motion to appoint Blanche Stuckey as Secretary to the Land Use Board was made by Chairman Armstrong, second by Patricia Dolan with Ciasullo, Fierro, Fitzgibbons, Honig, McGuire, Telischak and Horuzy also in favor.

Chairman Armstrong appointed John Fierro and Thomas Horuzy to be on the Completeness Review Committee with him.

Chairman Armstrong announced that Thomas Horuzy completed the Mandatory Training Course on January 18th and that all Board Members have taken the course.

7. OLD BUSINESS/NEW BUSINESS

a. 100 Plant Street, LLC – LU 13-002 Block 30, Lot 11.01 Memorialization of Resolution for Minor Subdivision

Chairman Armstrong asked for a motion to memorialize the lot line adjustment application. A motion to approve was made by John Fierro, second by Elliott Honig with Ciasullo also in favor. No other members were eligible to vote.

A motion to Open to the Public was made by John Fierro, seconded by Elliott Honig with all in favor.

9. <u>CLOSE TO THE PUBLIC</u>

A motion to Close to the Public was made by Chairman Armstrong, seconded by Patrick Fitzgibbons with all in favor.

10. CHAIRMAN'S AGENDA

a. Streetscape Project – Engineer Buczynski reported that everything is a "go" for April as far as the contractors being lined up. The County has given their approval for the road openings at a pre-construction meeting. Engineer Buczynski said that he has some shop drawings for the furniture that the Board can select some options. The decision was to go with the eight (8) foot benches. The benches are made in douglas fir or ipe. The ipe benches are around \$400 more. Ipe is a Brazilian hardwood which lasts longer. The douglas fir would have to be painted every few years. For the six (6) benches it costs \$2400 more but that amount is already in the budget for the benches.

Regarding the clock, Engineer Buczynski wanted to know if the Board would like numbers or roman numerals. All members agreed on the numbers and also on the "EST" located above the 1914 date. Discussion continued regarding the size and cost of the benches. Each bench costs \$1400 with the installation. The contractor said that this is his first job in the Spring; and as long as the snow goes away, they are ready to start on April 15th. Mr.

Horuzy asked if we have a completion date and Engineer Buczynski answered he thinks it will be around ninety (90) days.

Chairman Armstrong inquired on how donations to the Streetscape Project be handled. Mayor Ciasullo suggested that their names would be placed on a plaque on the lamppost, etc. Mr. Telischak asked if the lampposts have the hooks for banners and/or decorations.

b. Land Use Ordinances – The Ordinances are in the process of being codified and will be a link on the Borough website when it is finished. There was a discussion regarding the ordinance changes which were approved by the Board and sent to Council and if it is necessary for all of the pages to be published in the newspaper and the cost involved.

11. APPRECIATION

Mayor Ciasullo stated that he and the Council have to commend the Board members for all the work they did in 2013. They really appreciate it and the residents will appreciate it when the project is done.

12. <u>FUTURE PROJECTS</u>

Chairman Armstrong suggested that we work on the ordinances, the lake and the redevelopment district.

13. ADJOURNMENT

A motion to adjourn was made by Chairman Armstrong, second by John Fierro with all in favor.
