REGULAR MEETING FEBRUARY 13, 2012

The second regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on February 13, 2012.

Mayor Steve Ciasullo called the meeting to order at 7:00 P.M.

Upon roll call, the following council members appeared and answered the call: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings together with the time, location and agenda of same being sent to the New Jersey Herald and New Jersey Sunday Herald and posted on the bulletin board January 3, 2012.

Councilman Hann moved, Councilman Opilla seconded motion for approval of items on the Consent agenda.

- 1. Approval of Minutes from January 9th, Regular Meeting
- 2. Approval of Minutes from, January 23rd, Work Session
- 3. Approval of Minutes from January 30th, Special Meeting
- 4. Approval of Raffle No. 492 for a 50/50 to be held on October 6, 2012 by the Ogdensburg Fire Dept. Ladies Auxiliary.
- 5. Approval of Raffle No. 493 for a raffle to be held on January 1, 2013 by the Karen Ann Quinlan Memorial Foundation.
- 6. Approval of Raffle No. 494 for a 50/50 and Raffle No. 495 for a Tricky Tray to be held on March 24, 2012 by the Ogdensburg Fire Department.

At 7:02 p.m. Councilman Hann moved, Councilman McGuire seconded motion to go into executive session to discuss personnel. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.

At 7:35 p.m. Mayor and Council returned to the regular meeting. Councilman McGuire moved, Councilman Hann seconded motion to open the public session of the meeting. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.

Cliff Lowe, 18 Richards Street gave an update on the retention pond. Mr. Lowe mentioned that he is still waiting to hear from the Association and also wanted to know if Kevin Kervatt would be coming out to look at the pond. Mayor informed Mr. Lowe that Kevin would be coming out to look at the pond. Mr. Lowe also asked if there was anything with regard to maintaining the pond that the Borough could do. Mr. Lowe was informed that the Borough does not have the authority to do any kind of renovations to the pond only to do property maintenance. Resident asked about progress of the Edison House. Mayor informed the resident that the Borough has given the Historical Society some time to find funding that they could put towards the renovation of the house. That time has passed now and it is sitting in the hands of the Borough. The Mayor has spoken to Mr. Hadowanetz, Borough Historian and Mr. Hadowanetz said he is going to keep trying to seek funding. Right now the house has been cleaned up and Council will be deciding what can be done with it. Eric Muller from Wallkill Valley Football League attended the meeting to discuss the development of a regional recreation program with Hardyston, Hamburg, Franklin and Ogdensburg. Mr. Muller stated that right now Wallkill Valley does the football for the four towns in the area, which are Hardyston, Hamburg, Franklin and Ogdensburg. Mr. Muller informed Mayor and Council that Bob Schultz is in charge of Hardyston Recreation and is trying to develop

a regional sports program where all towns will be working together to give the kids a better sports program. This would include which fields would be good to use and what fields would be available. Mr. Muller stated that at this time Ogdensburg is not part of the program and they would like for Ogdensburg to join the other towns since Hardyston cannot support the other towns and pay for fielding funds. Fees paid for sports do not go to filed maintenance. Mr. Schultz is suggesting for the towns that do not wish to join the Rec group there would be a fee of \$50.00 per child, per sport, per In return they would do the fielding, which would include some field maintenance. Mr. Muller asked if someone from Ogdensburg would reach out to Bob Schultz to discuss options with the use of the fields. Mayor said he will give Bob Schultz a call. Jan Opt'hof, Construction Official, Sparta Township attended the meeting to ask Council to reconsider introducing the ordinance transferring the Building Department to the State. Mr. Opt'hof presented figures to Council for their review. The Mayor said he would like to stay with Sparta, but after speaking with other towns and officials he feels at this time the State would be a better deal since no extra fees would be imposed. The Mayor also mentioned that Ogdensburg is not locked in with the State. Mayor Ciasullo stated that Ogdensburg has always had a good working relationship with Sparta, but Ogdensburg has to try and control spending as much as possible.

There being no further business from the public, Councilman Hann moved, Councilman McGuire seconded motion to close the public session of the meeting. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.

Councilman Ingerto moved, Councilman McGuire seconded motion to introduce an ordinance entitled AN ORDINANCE AMENDING CHAPTER 8, BUILDING AND HOUSING, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF OGDENSBURG, AND TRANSFERRING JURISDICTION FOR THE ADMINISTRATION AND ENFORCEMENT OF THE UNIFORM CONSTRUCTION CODE TO THE STATE OF NEW JERSEY on first reading. Public hearing is scheduled for February 27, 2012.

BE IT ORDAINED by the Mayor and Council of the Borough of Ogdensburg, as follows:

Section 1. §8-1.1 of the Revised General Ordinances of the Borough of Ogdensburg regarding the function and duties of the Borough Uniform Construction Code Enforcement Agency is hereby repealed effective upon the assumption of jurisdiction by the State of New Jersey, Department of Community Affairs as provided below.

Section 2. The following new §8-1 of Chapter 8 of the Revised General Ordinances of the Borough of Ogdensburg entitled "Building and Housing" is hereby established as follows:

8-1 STATE UNIFORM CONSTRUCTION CODE ENFORCING AGENCY

8-1.1 **Relinquishment of Jurisdiction.** The Borough of Ogdensburg, pursuant to N.J.S.A. 51:27D et seq. and N.J.S.A.C. 5:23-4.3, hereby relinquishes its jurisdiction of the administration and enforcement of the Uniform Construction Code and hereby transfers jurisdiction for the administration and enforcement of the Uniform Construction Code to the Department of Community Affairs of the State of New Jersey. The transfer of jurisdiction pursuant to this section shall not take effect until the expiration of 120

- calendar days from the date of certified copy of this section is forwarded to the Department of Community Affairs or until the Department of Community Affairs shall exercise its jurisdiction to enforce the Uniform Construction Code, whichever is sooner.
- 8-1.2 **Records and Files.** The Borough of Ogdensburg shall deliver and make available to the Department of Community Affairs any and all records and files of the municipality necessary for the Department to carry out its function, and the Department is hereby authorized to transfer such records and files to a location designated by the Department.

Section 3. Repealer. All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

Section 4. Severability. If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

Section 5. Effective Date. This Ordinance shall take effect after publication and passage according to law.

Councilman Ingerto moved, Councilman Hann seconded motion to adopt the following resolution.

AUTHORIZING EXECUTION OF AN AGREEMENT WITH THE MORRIS COUNTY COOPERATIVE PRICING COUNCIL TO BECOME A MEMBER FOR THE PERIOD OF OCTOBER 1, 2011 THROUGH SEPTEMBER 30, 2016

WHEREAS, the Morris County Cooperative Pricing Council ("MCCPC") was created in 1974 to conduct a voluntary cooperative pricing system with municipalities, boards of educations, and other public bodies located in the County of Morris and adjoining counties; and

WHEREAS, the purpose of the MCCPC is to provide substantial savings on various goods and services to its members through the cooperative public bidding process; and

WHEREAS, the Borough of Ogdensburg desires to enter into an Agreement with the MCCPC, which is administered by Randolph Township as Lead Agency to become a member of the MCCPC for the period of October 1, 2011 through September 30, 2016.

BE IT HEREBY RESOLVED, by the Mayor and Council of the Borough of Ogdensburg, County of Sussex, State of New Jersey as follows:

- 1. Steven Ciasullo, Mayor and the Governing Body of the Borough of Ogdensburg hereby authorizes the execution of an Agreement with the Morris County Cooperative Pricing Council by the Township of Randolph as Lead Agency dated October 1, 2011 pursuant to N.J.S.A. 40A:11-11(5). Said Agreement is to become a member of the MCCPC for a five (5) year period from October 1, 2011 through September 30, 2016.
- 2. The Borough of Ogdensburg Clerk is hereby directed to submit a copy of this adopted Resolution, along with an executed Agreement, to Randolph Township as Lead Agency of the MCCPC.
- 3. This Resolution shall take effect immediately upon final passage according to law.

4. All appropriate Ogdensburg officials are authorized and directed to perform all required acts to affect the purpose of this Resolution.

BE IT FURTHER RESOLVED that his resignation be effective retro active as of February 5, 2012.

Councilman Hann moved, Councilman McGuire seconded motion to adopt the following resolution.

BE IT HEREBY RESOLVED by the Mayor and Council of the Borough of Ogdensburg for the Mayor to sign and the Clerk to attest to the Deed of Easement for Access for Hawthorne Park Club and Armstrong Easements.

NEW BUSINESS

Councilman Amodeo informed Mayor and Council that the renewal for the permit for the Federal Migratory Bird Depredation is due on March 31, 2012 and that he will be working on it. Councilman Amodeo also spoke about badges for Heaters Pond for the 2012 season and stated that there are plenty of badges left over from previous years that we can use. Mayor Ciasullo spoke about a letter received from the girl's softball team requesting use of the field by the Firehouse. Councilman Ingerto explained that Ogdensburg Recreation Association takes preference over the woman soft ball team, Little League and Babe Ruth. The Mayor briefly mentioned about a boat rack for Heaters Pond. Further discussion will be forthcoming. The Mayor also spoke about a letter received from Sussex County with regard to procedures to follow when a municipality is having a parade, or any event using county roads. Councilman Opilla informed Mayor and Council that there is a problem with the billing for the water bills and the amounts being charged to some of the residents is lower then it should be. Councilman Opilla spoke with Municipal Software to see if they knew why this was happening and was told they have no idea why that would happen. Councilman Opilla will be looking further into the matter. Council briefly discussed doing a bond ordinance to complete the installment of new meters in the Borough. Further discussion will be forth coming.

OLD BUSINESS

Mayor Ciasullo talked about the new location for the Recycling Center and that it is doing well for the first weekend. Surveillance cameras will be installed this week and Council also discussed signs to be put up. Council will be deciding what could be done with the old garage. There was a request made to use the old garage for the VFW flower sale during Easter. Councilman Hann mentioned that the budget was submitted to the auditor for review and the CFO is still waiting to get the figures from the state.

Councilman Hann moved, Councilman Opilla seconded motion for review and payment of vouchers. Council had a brief discussion on a bill for the Fire Department for hoses. Councilman Hann informed Council that the money was encumbered last

October. Council also discussed clothing allowance for the Fire Department. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.
