### REGULAR MEETING JULY 9, 2012

The seventh regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on July 9 2012.

Mayor Ciasullo called the meeting to order at 7:00 PM.

Upon roll call, the following council members appeared and answered the call: Amodeo, Andrews, Hann, Ingerto, McGuire. Absent: Opilla.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 3, 2011.

Councilman Hann moved, Councilman McGuire seconded motion for approval of items on the consent agenda.

Councilman McGuire moved, Councilman Hann seconded motion to open the public session of the meeting. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire.

Wasco Hadowanetz, Borough Historian came before Council to ask for another extension of time to finding funding for the Edison House. Mr. Hadowanetz asked for a three month extension. Mayor explained to Mr. Hadowanetz that he understands everything but the Borough has everything in place along with receiving estimates to proceed with the demolishing. The Mayor feels that Mr. Hadowanetz was given amble time to search for funding and appreciates all the work and time that went into it. Council feels that right now the house is a potential fire hazard and it is unoccupied which is not a good thing. Mayor asked Council if they would like to take a vote to extend the time for three months. Councilman Hann moved, Councilman McGuire seconded the motion to do a resolution to extend the time to three months, which would be to September 30, 2012, to finding funding and at the end of the three months if the Historical Society doesn't present options for funding to purchase the property at the full price the Borough will then proceed with the demolition of the house. Yeas: Hann. Nays: Amodeo, Andrews, Ingerto, McGuire. Motion did not pass, Borough will proceed with the demolition.

Pat Sabourin, 13 Wilson Drive asked what happened to the signs for the turtles. Mayor informed Mrs. Sabourin that it was only for a short time and the signs were picked up. Mayor asked how the 5K Run went. Mrs. Sabourin informed Mayor and Council that the run went well and the First Aid Squad made almost \$4,000. Jean Castimore stated that it sounded as if the Borough is leaning against having a parking lot. Mayor mentioned that with the streetscape project coming up they will have to see. Ms. Castimore asked if a parking lot could be part of the streetscape. Mayor said the amount of money that will be given for the streetscape may not be enough to include a parking lot and they will have to see when the time comes.

There being no further business from the public, Councilman Hann moved, Councilman McGuire seconded motion to close the public session of the meeting. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire.

## **NEW BUSINESS**

Councilman McGuire informed the Mayor and Council that the 100<sup>th</sup> Anniversary of the Borough will be coming up in 2014 and feels that the Borough should start planning for it. It was agreed that a committee should be formed to work on the project. Having fund raisers were spoken about and also having different events at different times of the year. Further discussion will be forth coming. Mayor briefly mentioned that the anniversary of Heater's Pond was this month meaning July and mentioned that he would like to have a fund raiser just for Heater's Pond.

#### **OLD BUSINESS**

Mayor mentioned that he has the estimates for the demolition of the house from Fred Rowett, which is \$1,700 and for three dumpsters from Grinnell is \$850.00 each. A target date hasn't been set as yet, but once everything is out of the house then a definite date will be set. Council spoke briefly about the aerator for the pond and the lifeguards have their schedule through July and August.

At 7:50 p.m. Councilman McGuire moved, Councilman Hann seconded motion to go into executive session to discuss contract. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire.

After returning from executive at 8:05 p.m. Mayor and Council discussed the water billing and the inaccuracies that have come up. Mayor Ciasullo said he will speak with the Water Cashier to see if she has call about the program.

Councilman McGuire moved, Councilman Hann seconded motion for review and payment of vouchers. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire.
