### **REGULAR MEETING**

### JUNE 9, 2014

The sixth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on June 9, 2014. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Amodeo, Astor, Hutnick, McGuire, Opilla, Rizzo. Also in attendance was Borough Attorney, Richard Brigliadoro.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 2, 2014.

Councilman McGuire moved, Councilman Astor seconded the motion to introduce an ordinance entitled AN ORDINANCE PERMITTING MUNICIPAL EMPLOYEES OF THE BOROUGH OF OGDENSBURG TO REQUEST DIRECT DEPOSIT OF NET PAY PURSUANT TO N.J.S.A. 52:14-15F(a) on first reading. Public hearing is scheduled for June 23, 2014.

**WHEREAS**, N.J.S.A. 52:14-15f(a) provides that upon the adoption of an ordinance, the governing body of a municipality may provide for the deposit of the net pay of any employee of the municipality or of a board, commission, bureau, department or other public agency thereof, in a specific banking institution in a designated checking account, savings account or share account; and

**WHEREAS,** N.J.S.A. 52:14-15f(a) provides that whenever an employee indicates in writing to the proper disbursing officer his or her desire to have his or her net pay deposited, the disbursing officer shall make the deposit in the respective banking institution on behalf of the employee.

**NOW THEREFORE, BE IT ORDAINED,** by the Governing Body of the Borough of Ogdensburg, located in Sussex County, State of New Jersey according to the following:

- Any employee or elected public official who receives compensation from the Borough of Ogdensburg shall be permitted to have the option to indicate in writing to the proper disbursing officer his or her desire to have his or her net pay deposited in accordance with N.J.S.A. 52:14-15f.
- Section 2. The disbursing officer shall make the deposit in the respective banking institution on behalf of the employee when the disbursing officer receives a request in writing from the employee to have his or her net pay deposited.
- Section 3. The Governing Body may make available for such employees who have net pay directly deposited any information concerning net pay, any accompanying information approved for distribution with net pay and W-2 forms in accordance with applicable federal law.
- Section 4. If any Section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the Section, paragraph subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- Section 5. All ordinances or parts of ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
- Section 6. This Ordinance shall take effect after final passage, adoption and publication according to law.

#### OLD BUSINESS

Council discussed the installation of water meters and there are about 70 meters left to install. Mayor discussed having peddlers at the 100<sup>th</sup> Anniversary celebration. He asked the attorney to review the ordinance on Peddlers Licenses to find out if the Borough had to allow soliciting at the celebration. Mayor Ciasullo spoke about the Main Street Streetscape and informed everyone that the project is going along nicely, everything is looking good and is on schedule. There was a complaint from a resident who lives on Main Street regarding his driveway and water now collects in the driveway, which never did before. The resident feels it is from the new sidewalk that was put in. The Mayor said he would look into it. There was a question regarding the school property being done. Mayor Ciasullo informed everyone that the school was never in the plans. Street sweeping was discussed and the old part of town has not been done yet. The work is getting done very slowly and the Borough and sweeping company are not in agreement with the way the work is getting done. Councilman McGuire mentioned that the codification of the ordinances was in the process of being reviewed by our past attorney and the Borough has now turned it over to the present attorney to look at the updates received from the codification company. Councilman McGuire also mentioned that two new cameras have been installed down at the Department of Public Works for the recycling center.

### **NEW BUSINESS**

Councilman McGuire mentioned that the lights in front of the Borough Hall are not working. It has been looked at three times and apparently there is a problem with the circuit breaker and timer. It will be looked into. Councilman McGuire also mentioned that the Teachers Association would like to be involved with the 100<sup>th</sup> Anniversary and it was mentioned that they would like to do Sand Art. The Mayor also mentioned that the Fire Department will be doing the Beer Garden. Councilman Hutnick informed Mayor and Council that he was at a meeting with the other organizations and everything is status quo with the 100<sup>th</sup> Anniversary. Councilman Hutnick also mentioned that on Saturday, June 14<sup>th</sup> the Drug Alliance will be having an end of the year party and the Historical Society had their barbeque and it turned out very nice. Also the Sterling Hill Mine wants to paint the old railroad trestle and they are looking to open the Observatory to have schools come in. The Sterling Hill Mine definitely wants to be a part of the 100<sup>th</sup> Anniversary celebration. The Borough is still looking for a marching band.

Councilman McGuire moved, Councilman Hutnick seconded motion to open the public session of the meeting. Yeas: Amodeo, Astor, Hutnick, McGuire, Opilla, Rizzo.

Cliff Lowe, 18 Richards Street informed Mayor and Council that his Scout Troop will be ready to start painting the pavilion at Heaters Pond. Mr. Lowe also asked about a Food Handler's License for the Scouts to sell funnel cakes at the 100<sup>th</sup> Anniversary celebration. Jean Castimore asked if the peddler's license is for non-profit. The attorney will be checking the ordinance on it. Ms. Castimore also asked if the fund raiser is still happening. Mayor informed Ms. Castimore that the fund raiser was cancelled. Pat Sabourin of the First Aid Squad reminded everyone that the 5K Run is coming up on June 21, 2104.

There being no further business from the public, Councilman McGuire moved, Councilman Astor seconded motion to close the public session of the meeting. Yeas: Amodeo, Astor, Hutnick, McGuire, Opilla, Rizzo.

Mayor Ciasullo mentioned that the department heads have been showing up at the regular meetings and he really appreciates it but announced that he would like to change the day for the department heads to attend the meetings from the first Monday of the month to the fourth Monday of the month, which would save time on the first Monday meeting and allowing more time to discuss things at the fourth meeting of the month. The Mayor also mentioned that he received another complaint about the garbage pickup with mixing recycling and garbage. The Mayor has spoken to the owner and will also look into the garbage contract.
