REGULAR MEETING

OCTOBER 15, 2014

The tenth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on October 15, 2014. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Astor, Hutnick, McGuire, Rizzo. Absent: Amodeo. Also in attendance was Attorney Brian Hack.

OLD BUSINESS

Mayor Ciasullo discussed the open position for a Tax Collector. The Mayor stated that he will be looking into a shared service with another town if possible. Further discussion will be forth coming.

NEW BUSINESS

Mayor Ciasullo discussed the Best Practices with Council. The Mayor informed Council that we have enough yes answers to meet the requirements and that Ogdensburg scored 84%. Councilman McGuire spoke about information received from a resident at the last meeting about having a town wide garage sale. It could be sponsored by one of the organizations in town if there is any interest. Information will be sent out to the various organizations.

There was discussion among Council regarding pet waste disposal bag dispensers. The Board of Health had discussed and voted on purchasing pet waste disposal bag dispensers for residents who have dogs. There have been a lot of complaints regarding residents who are walking their

dogs and not cleaning the dog waste. Board of Health feels if dispensers are given out to pet owners that it would help with the waste. Council agreed with the idea and will be talking with the Board of Health. Councilman Hutnick mentioned that the Fire Department recently had an inspection of their trucks and one truck failed the inspection for pump issues. Further discussion will be forth coming. Councilman McGuire informed Mayor and Council about the medical coverage for the retirees. Aetna insurance has dropped small group coverage for 2015 for Medicare recipients. The Borough will be looking into another plan for the retirees. Councilman McGuire also asked the Mayor if the Borough will be doing RFP's for the professionals this year. The Mayor said he would like to and to look at the positions for Attorney and Engineer. An ad will be placed in the New Jersey Herald.

Councilman McGuire moved, Councilman Hutnick seconded motion to open the public session of the meeting. Yeas: Astor, Hutnick, McGuire, Opilla, Rizzo.
