OLD BUSINESS

State Fire Marshal Notice of Violations – Councilman Nasisi explained we have the new doors installed; maybe DPW can [stain them]. Is someone going to notify the State the doors are in?

Mr. McBriar commented we should notify them that was the final item. Mr. McBriar asked when was the next reporting date. Ms. Hough commented it was November 10 and explained she went on REIMS but it is only to request an extension.

Mr. McBriar commented maybe just let them know these open items have been closed out.

Councilman Nasisi commented he can call the inspector directly.

Mr. McBriar commented ok if you don't mind.

Downstairs Bathroom – no update.

Borough owned properties sale – Councilman Nasisi explained he still has a comprehensive list of some things [properties]; the process has started.

DPW/Personnel – Mayor Hutnick commented this can be taken off the agenda everything is fine.

Senior Citizen of the year – Mayor Hutnick explained he is still receiving some names; we are keeping it on the agenda.

Predmore Road – Mayor Hutnick commented he believes Predmore Road is done; he has to see if they finished the land scaping. Mayor Hutnick commented this can be taken off [the agenda] the project itself is completed. They were waiting on the tree to be taken down and then fix the rock bedding that was there.

Local Planning Grant – No Update.

NEW BUSINESS

Best Practices – M. Marceau, CFO explained he submitted best practices that we get every year. This year was 56 questions they have a lot of sub questions so it was actually 69 questions. Mr. Marceau commented 43 were scored, 13 were unscored, you had to get 24 or more to keep one hundred percent for your state aid. The Borough had 31 yes so, we had plenty of yes answers.

Mr. Marceau explained he felt the questions were very tricky this year and explained some of the questions. Robin and I filed this last week. There were lot of question regarding the lead paint. Those questions were unscored but they did ask if the Borough would be interested in a grant if they keep going with this so obviously he said yes.

There was a brief discussion on the lead paint questions.

Property Maintenance Code from Land Use Board – Mayor Hutnick explained the Land Use Board has been going over our property maintenance codes and things like that. In all of your folders you will see what has been submitted. The Board is looking for approvals; what he asks is that you read through the two packets you were given if you have an thoughts email him so he can relay those thoughts to the Land Use Board at their November 22 meeting. The Land Use Board has put a lot of work into this.

There was a discussion on the property maintenance code and time line to pass this if the Borough does an ordinance.

Auction Date for Borough Properties -

Mr. McBriar commented he had the opportunity to speak with a representative from Max Spann regarding the auction. He submitted some proposed dates, February 23, 30, March 2 and March 9, 2023. It makes since to do the March 9th date to increase marketing and exposure. So, one of three items he would like to discuss with you this evening is the date because we should adopt a resolution advising the public when that would be. Is there a consensus with regards to any of those dates?

Councilman DeMeo asked when the budget had to be complete.

Mr. Marceau explained we haven't received the new dates yet but typically intro will be in April and adoption in May.

Councilman DeMeo commented so what date we pick doesn't matter.

Mr. Marceau commented probably the later we can push this the better.

Mr. McBriar commented so March 9th if you want to get a date after that he can as well.

Mayor Hutnick commented we can try March 9th, 2023.

Mr. McBriar commented tentatively we will look at the March 9th date.

Mr. McBriar commented the other option the Borough has to decide is whether it is a live on-line auction through their website www.maxspann.com or if this will be done at the municipal building. They have started to do more of the on-line auctions for their government clients.

Mayor Hutnick commented to go with the on line you get better exposure on line.

Mr. McBriar explained there are different types of auction procedures; one is auction absolute where the properties advertised is sold to the highest bidder regardless of price. There is the undisclosed reserve which is where the Borough Council and the auctioneer Max Spann determine a floor and it is an unpublished floor and if it exceeds that then the sale would commence and if it below that you would have discretion of approving it or disapproving it. There is also a published bid where we would determine what the minimum bid is and if it exceeds that minimum bid it would be sold if it does not then it would not.

Mr. McBriar commented in his experiences in doing these for governing clients we usually try to keep the greatest discretion for the municipalities so that whatever the sales price is for a given property we will always be subject to confirmation from this Council. So, he thinks that way may be the best. Sometimes property sell, sometimes they don't; but will sell later.

Mr. McBriar commented if there is a consensus he will speak again with the representative from Max Spann and include it in a resolution and we will take it from there.

Councilman DeMeo asked you are recommending the unpublished reserve. Mr. McBriar commented yea. Councilman DeMeo commented if that is your recommendation he doesn't have a problem with it.

Councilman Nasisi commented on getting an appraisal for the properties. Mr. McBriar commented the minimum bid would start the floor, obviously there you can get one bid with the minimum bid.

There was a discussion on the auction, value of the properties and these properties being recent in rem foreclosures,

Personnel – Mayor Hutnick explained we received several resumes for Deputy Clerk, Robin is going to go through those and pull the resumes she feels we should interview based on their criteria.

Ms. Hough explained the ad was published but it was really for four positions and explained.

Christmas Party- Mayor Hutnick commented we can have the Christmas Party at the fire house and have pretty much any date we want. It will be a little different this since the fire house doesn't have a kitchen, so we will do a buffet again between Gemma's and the Atlantic Manor. Mayor Hutnick commented he was thinking of extending it this year to families, so instead of just saying it is you and a guest what do people think about bringing kids. The Council agreed and the Mayor asked about dates. It was decided on Sunday, December 11, 2022 beginning at 11:00am.

Mayor Hutnick commented if you noticed on Main Street we now have banners for our fallen Veteran's, Robin coordinated and headed the project. Mayor Hutnick commented he received a letter from the VFW on behalf of Robert A. Madden Veterans of Foreign Wars Post 10152. Mayor Hutnick read the letter to the Council.

PUBLIC SESSION

Councilman DeMeo moved, Councilman Nasisi seconded motion to open the public session of the meeting. All were in favor.

Craig Taylor, Kennedy Ave. Ogdensburg. Mr. Taylor handed a newspaper article from 24 months ago it was regarding a guard rail request in front of his house. Mr. Taylor explained he has two dead trees that have to come down and that is going to leave his whole front yard open as you are coming from Franklin towards the tunnel. There was an accident there this morning and they hit a tree in his yard. Mr. Taylor asked if something can be done and explained his concern when the two trees are down it will leave his whole front yard open now. The guard rail there is falling apart; it has been hit a couple of times and explained. Mr. Taylor also questioned mark outs going down Corkhill.

There was a brief discussion on the mark outs.

Steve Ciasullo, 37 Glenbrook Road, Ogdensburg questioned the appropriation approval; how did you move and what line items did you move it too. Mike Marceau explained the transfer resolution.

Mr. Ciasullo asked the properties that you guys choose to go in the resolution [ordinance to auction off properties]. How did you pick these and who went over them?

Mr. Marceau commented these are brand new foreclosures; they just became Borough properties.

Mr. Ciasullo commented so you are saying the ones on Richardsville just became [Borough properties] those three.

Ms. Hough commented they were in rem foreclosures.

Mr. Ciasullo commented he thought they were old. Did anyone look at those properties? Are they all the same deeds or different deeds?

Mr. McBriar explained they are individual block and lots that had accrued their own tax liens over time.

Mr. Ciasullo commented separately. Mr. McBriar commented that is correct.

There was a discussion on the properties to be auctioned off.

Mr. Ciasullo asked if you can offer them to neighboring property owners.

Mr. McBriar commented if they don't comply with the zoning code one option is the municipality can negotiate with neighbors. So, if they are undersized lots that is an option and the policy behind that is if it is an undersized lot and the neighboring individual wants to purchase it one of the conditions of sale is we require that they merge it with their neighboring lot and that will take a non-conforming lot and bring it to conformity. But it is not a requirement for every sale to privately negotiate with neighbors.

Councilman Nasisi commented there are a lot more properties the Borough owns.

Mayor Hutnick commented we started off with these foreclosures; that is what was chosen so that is what is going forward.

There being no further business from the public, Councilman DeMeo moved, Councilman Nasisi seconded motion to close the public session of the meeting. All were in favor.
