Mayor Hutnick commented at this time he is going to turn the meeting over to retired Chief Lott from the VFW.

Ms. Hough commented Mayor Hutnick gave her the ok back on June to due this project with the students from Vo-Tech; they did a fantastic job remembering the Veterans that lost their life, one was from WW I, four from WWII and one from Vietnam.

Ms. Hough introduced Lt. Robert A. Madden Veterans of Foreign War Post 110152, Commander Stephen Davis, Chief George Lott, Retired and Trustee Thomas Hart have certificates for the students from Vo-Tech for the great job they did.

At this time Chief Lott took over the presentation.

**WHEREAS**, the Borough of Ogdensburg ("Borough") previously instituted a Home Improvement Program ("Program") for the purpose of providing low cost home improvement financing to qualifying homeowners; and

**WHEREAS**, as part of this Program, the Borough granted a loan in the principal amount of \$19,475.00 to be used to rehabilitate property located at 11 Glenbrook Road, Ogdensburg, New Jersey, identified on the Official Tax Maps of the Borough as Block 26.06, Lot 15; and

#### **OLD BUSINESS**

Mayor Hutnick explained the only thing we have to address under old business is personnel; that is because we were able to hire a deputy clerk. We had several candidates apply for the job we had three candidates that we interviewed and after careful consideration after the interviews we decided on Maria Mascuch. Maria was also a former employee back in the ninety's she is fully qualified and ready to start work.

Mayor Hutnick asked if anyone wanted to go over anything in old business.

Councilman Ciasullo asked how did you end up with the property maintenance code.

Mayor Hutnick commented the property maintenance code is going through the Land Use Board they are looking to make adjustments so they submitted a copy back to the Council. It is some updates that needed to be done in regards to high grass, maintenance, garbage, trash; we are making changes and updates and explained.

#### **NEW BUSINESS**

Police Contract – Mayor Hutnick commented he has already opened the negotiations with the police we are starting to review the old contract, the new contract. The CFO and himself have been starting to go over it, so as he gathers the information he will be able to present it. We are in the very beginning stages of it. He believes that we will come to an agreement sometime during the first quarter of next year; he doesn't want to go anywhere past that.

Solid Waste and Recycling contract – Mayor Hutnick commented this one is going to hurt; we went out for bids we received one bid from Blue Diamond our current company; they are the only one that bid. They are pretty much the only one that handles a lot of local towns. Mayor Hutnick explained what the Borough is paying current and what it will be paying with the new increase; which is a 24 percent increase. Mayor Hutnick explained we will be looking into any other options. Mayor Hutnick commented with this number coming in we are going to have to really look at our budget and are really going to have to make cuts and explained. We will address this once budget talks start in January.

Mayor Hutnick commented there is some good news we have secured two more grants. We secured Phase 2 for Edison road for \$100,000.00 to continue on Edison. He doesn't have the exact distance yet. The other grant is phase 2 of Passaic Street for \$145,000.00 same applies we were just told that we are receiving those grants. The reason we are getting these grants when

other roads in town need to be paved is because they are connector streets through other towns and that is what the State wrote the grants for. The two roads that are connected to Sparta are the two roads we received grant money for.

Mayor Hutnick explain water repairs needed at the pump house up on Edison. Besides that, entire building we need a roof repair it is leaking we had two bids to do the job. One bid to repair the roof is for \$20,000.00 the other bid to do the exact same work is \$5,375.00. We will budget for that it isn't going to happen in the next month but we will budget for that. We also have an estimate to replace the entire building, by replacing he means remove. Remove the building and he believes put a small say shed repipe everything but that is about \$450,000.00 to do that. Unless we can come up with a major grant for that we will go to water repairs and maintenance as we have been doing. Set a goal to get the building replaced that we won't have to worry about it.

Mayor Hutnick commented on lead piping. The State is on an initiative to replace all the lead pipes in all the towns. The hard part is finding them and identifying them. Right now, according to our records we have 916 lines according to our water operator 136 are lead. We need to begin the process of finding them identifying them and putting a plan together with the State to tell them how we plan on fixing them. We have to have everything identified and repaired by July of 2031. It sounds like it is really far away but it is not. We will begin that process. The lead pipes are the pipes going to the houses; those are the lead pipes they are looking to replace which means digging up people's yards and so on. We will receive a lot of push backs from the residents but it is a State mandate.

Councilman Ciasullo asked about the police contract; is this the first-time you guys are talking about it?

Mayor Hutnick commented it is the first time we are talking about it in public.

Councilman Ciasullo asked are members of the Council involved in the negotiation. Mayor Hutnick commented they will.

Mayor Hutnick commented currently it is him, CFO and the police; when he has the information, we can get more people involved instead of have a bunch of people to start with.

Councilman Ciasullo asked does the CFO have any other authority in the town besides the CFO that he doesn't know about. Is he a manager or anything like that?

Mayor Hutnick commented no he is the CFO. The CFO and mayor have been talking to the police but he doesn't have anything to distribute to anyone yet; as soon as he gets something we can pull it all together.

Mayor Hutnick asked if anyone else had anything.

Mayor Hutnick commented Councilman Alvarez if you need to [leave the meeting] you can.

Councilman Alvarez left the meeting via phone at 7:25pm.

# **PUBLIC SESSION**

Councilman DeMeo moved, Councilwoman Cowdrick seconded motion to open the public session of the meeting. All were in favor.

Toni Erb, 26 Edison Ave. asked about the garbage pick and if the commercial businesses had their own pickup.

Mayor Hutnick explained they do.

Ms. Erb asked about the lead pipes. Mayor Hutnick explained

Carol Hart 5 Lincoln Ave. asked about the properties being auctioned are they all over town and asked if they are developable?

Mr. McBriar asked are these the properties the Borough just foreclose on? The Borough isn't making any representations as to the suitability for development. So, these are being auctioned off by an auction company the dudiligence is really on the prospective bidder as to what can and cannot happen there. Again, these were tax sale certificates that we started the legal action to foreclose. Again, the borough isn't making any representation it goes through the auction process.

There being no further business from the public, Councilman DeMeo moved, Councilwoman Cowdrick seconded motion to close the public session of the meeting. All were in favor.
