Seconded by Councilman Alvarez.

#### **OLD BUSINESS**

Local Planning Grant - No update.

Property Maintenance Code from Land Use Board – Mayor Hutnick asked if anyone had a chance to look through this. There were no comments.

Police Contract – Mr. Marceau, CFO commented he heard from Officer Geene he is going to review everything and get back to us.

First Aid Squad – Mayor Hutnick asked Mr. McBriar if there were any updates. Mr. McBriar commented not that he is aware off he thinks there is still an outstanding permit.

#### Budget -

Mr. Marceau referred to his handout on the budget figures. Mr. Marceau explained we have to introduce the budget at the next meeting in order to go before the Local Finance Board. We are three hundred and thirty-one dollars under our levy cap which is a 6.29 percent increase, it comes out to about two hundred and ninety-eight dollars on the average assessed home. The vast majority of that is the increase in health insurance, the increase in garbage and recycling and police retirement increase.

Mayor Hutnick asked if there were any questions. Mr. Marceau commented at this point if you want it to get it any lower the only shot is to anticipate more fund balance. Everything else has been held flat other than small increases for utilities and things like that due to inflation. Those increases are hurting all towns; those three items have never been outside of the appropriation cap; they have been outside the levy cap and this year all three are.

Mayor Hutnick asked how will the moneys from the property apply; how will that affect this or will it.

Mr. Marceau commented until we close and everything he doesn't see the State allowing us to put anything in the budget [this year]; we can use that next year.

Mayor Hutnick commented then that will make up for some of the fund balance we are going to use.

Councilman Ciasullo referred to page eight; did we not close the salary and wage for the park that was discussed here.

Mr. Marceau commented it was mentioned as a possibility but no one told him it was approved.

Mayor Hutnick commented we are going out for lifeguards, we have to leave the numbers in there for now. If we don't get any lifeguards then we can't open the lake then that money doesn't get used.

Councilman Ciasullo asked about Ogdensburg Day.

Mr. Marceau commented we do need some sort of cushion somewhere; we all know the plans we make today are not what is going to happen. If you take out ten thousand you are not even reducing the budget a half of percent.

# **NEW BUSINESS**

Newsletter

Mayor Hutnick commented Robin has done the newsletter everyone has a copy of it.

There was a discussion on the draft newsletter, there will be a meeting date added for the Historical Society, it was suggested to put in red on the front page of the newsletter information on the solid waste pickup change and to add a page in the inserts with the change.

#### **PUBLIC SESSION**

Councilman DeMeo moved, Councilman Poyer seconded motion to open the public session of the meeting. All were in favor.

Rosa Collins, President of the Wallkill Valley Little League Baseball. Ms. Collins asked about the field use application that was submitted. As of the sixth it said our application was approved; she wanted to clarify the days and conflicts with the dates with Kaboom. Ms. Collins also asked about the maintenance of the fields.

Councilman Cowdrick explained the concern of having Kaboom and baseball using the field at the same time.

Ms. Hough commented she has had other teams ask about using the field; is it one team at a time to use the field.

Mayor Hutnick commented he believes generally we only let one play at a time because the fields will over lap during games and gave an example.

There was a discussion the field and the application; Wallkill Valley Little League Baseball application was approved for Monday, Friday, Saturday and Sunday. They have to submit the fee, and an amended application with the approved days, fee of \$250.00, and list of coaches. Both teams Kaboom and Wallkill Valley Little League may work together if one isn't using the field. Storage for baseball equipment was also discussed.

Jim Lame, Ogdensburg resident stepped forward. Mr. Lame commented he was top bidder on the land off of Edison. He is here to see what the procedures are to get access to his land. Mr. Lame commented he is looking at the land that is located behind the water tower which would be 144 Edison Ave. referencing a chart, he had.

Mayor Hutnick asked are you currently land locked. Mr. Lame commented he is currently land locked there is no way to get to his land what so ever.

Councilman Ciasullo asked Mr. Lame if he had started the process yet.

Mr. Lame commented he hasn't started the process yet, but if he can't get access to it there is really no sense in having it. Mr. Lame explained how the handout of the tax map and how he would like to get an easement through the Borough property behind the water tank to his property.

There was a discussion on an easement, this property and surrounding properties.

Councilman Ciasullo asked Mr. McBriar what would the process be once this is figured out.

Mr. McBriar commented we understand there is a 30-day closing period with the contract, once we have the scope of this request in greater detail; certainly, the Borough is free to grant a license or easement agreement on the property.

Councilman Ciasullo asked if we can extend his thirty days. Mr. McBriar commented he doesn't see that being an issue; we will certainly need time, we will have to get our Borough engineer involved to maybe scope this out as well. Mr. McBriar commented we understand the timing and the request; we will work with you on the timing and closing.

Mr. McBriar commented as we get further along there will be a survey involved, legal bounds and description, describing the easement. This is the first step and we can reach out to our engineer and share with him any drawing you provide to us.

There being no further business from the public, Councilman DeMeo moved, Councilwoman Cowdrick seconded motion to close the public session of the meeting. All were in favor.
