OLD BUSINESS

Borough Hall Revitalization –

Councilwoman Ruitenberg commented some things are being worked on.

Lead Line Replacement Plan – Poyer/Ciasullo/Ruitenberg

Councilman Ciasullo commented he spoke with Robin and looked over some paper work she had from Trenton. Councilman Ciasullo explained he called and left a message [with DEP] to go over the letters we have to send out by November. It looks like every water customer is going to get a letter mailed to them. Anybody that we know has a service line of galvanized or lead will be getting certified letters; at this point we don't have any knowledge of that.

Councilman Poyer commented he believed that we do have one or two that were submitted [by survey].

Councilman Ciasullo commented what we should do is those people that did the survey should get a certified letter. We should probably before November have the guys dig a little outside the inspection hole because if we think every house on the street has it they will all have to get a certified letter. Councilman Ciasullo explained a report that is due in November.

There was a discussion on the letter, the sample from the state and a letter that was sent out by Sparta.

Councilman Poyer explained the best place for [DPW to start testing] is on Spring Street and where it crosses over to High Street; that is where we assume is probably the only place in town that still has lead pipe. This information was according to the maps DPW had showed us.

Employee Handbook Revisions – Councilwoman Ruitenberg explained it's a work in progress.

Purchasing Policy Changes – Mr. Marceau explained he sent the proposed resolution to Mr. McBriar for review. The resolution was based off of samples he received with different statue references; Mr. McBriar was going to help clear that up. Hopefully we will have this by the next meeting.

Lead paint inspections – Mayor Hutnick commented hopefully by next meeting he will have the resolution for the lead paint company.

Ogdensburg Mass communications system – Councilman Ciasullo commented he reached out to Mr. Astor and the school [regarding the company they use]. Mr. Astor hasn't gotten back to him. Councilman Ciasullo explained he also reached out to Civic Plus and Nextel.

There was a discussion on the school and who works the mass communications at the school.

NEW BUSINESS

Police Department – Mayor Hutnick asked Sgt. Sanfilippo if he has anything to say. Sgt. Sanfilippo commented what is the decision going to be regarding the promotion.

Mayor Hutnick asked Mr. Maddaloni if the discussion has to be in executive to discuss the police whether or not to move forward with regards to a promotion.

Mr. Maddaloni asked will the individual person be discussed and identified?

Mayor Hutnick commented he has already been identified and sitting next to you.

Mr. Maddaloni asked Dave Cowdrick if he consents to having the discussion in public?

Dave Cowdrick commented yes.

Mr. Maddaloni asked Dave Cowdrick to state his name and address for the record.

Dave Cowdrick stated his name and address for the record.

Mayor Hutnick commented we sent out for the list; the list came back as he requested.

Sgt. Sanfilippo commented the eligibility list.

Mayor Hutnick commented there is only one name on the [certified] list. Mayor Hutnick asked what is the next process.

Mr. Maddaloni explained if there is one name on the certification and you have a vacancy that you are going to fill.

Councilwoman Ruitenber commented no we don't.

Mayor Hutnick commented we don't have a vacancy; we have retirements coming up next year, we have an individual that is been charged with being a Field Training Officer. He is training our two new [officers] coming in. He has passed everything he needs to pass.

Mr. Maddaloni commented he read all that from the minutes of the last meeting.

Mayor Hutnick commented he received the certified list.

Mr. Maddaloni commented you don't have a bonified vacancy; that is the concern.

Mayor Hutnick commend right.

Mr. Maddaloni asked if the table of organization allows for an extra [Sergeant]?

Mayor Hutnick explained we can change it to accommodate for three sergeants at this time.

Mr. Maddaloni commented provided you have the right of Council to vote on the table of organization to allow for the additional spot and you have a vacancy then you can go ahead.

Ms. Hough asked if that was the agreement the PBA gave us that they were in agreement with changing it [the contract].

Mr. Maddaloni asked is the table of organization something the PBA negotiates with the Borough; legally it isn't subject to the negotiations and explained.

Sgt. Sanfilippo explained the PBA had to provide a letter saying they were good with making the exception.

Mayor Hutnick read addendum B from the PBA they agree to temporarily create a third position for sergeant which is the modification they sent.

Mr. Maddaloni commented apparently PBA has consented. This should be taken up and voted on by the Council before you fill the position.

Mayor Hutnick commented last meeting we discussed getting a certification list.

Mr. Maddaloni commented you have that now.

Councilwoman Ruitenberg asked do we have the eligibility list.

Mr. Maddaloni commented they are two different lists.

Ms. Hough commented yes; she has both of them.

Mr. Maddaloni asked you have both certification and eligibility.

Ms. Hough commented correct.

Mr. Maddaloni asked how long is the certification list good for?

Ms. Hough commented the end of November.

Mr. Maddaloni commented you have until November to move off that certification list. In order to do that the first thing, you need to do is establish the extra position; you can do that by resolution given that you have the PBA approval, if you need it. But the question is do you need it; is it in the contract. Then the question comes do we fill it; it is a couple of step process.

Councilman Ciasullo commented we would have three sergeants if the guys don't retire.

Mayor Hutnick explained we have two sergeants, one submitted for retirement, we have an officer that is currently training two new officers coming in, they are all the same rank. He [Ptl. Cowdrick] has earned it, he has taken the test, he is ready there is no reason to have one officer train another officer. It should be a sergeant training the other officers.

Councilman Ciasullo commented he doesn't think it is a great idea to just add a sergeant.

Mayor Hutnick commented let's say we don't add it and we wait until after the academy.

Councilman Ciasullo commented he is just saying what if Ogdensburg ends up with three sergeants. We have to discuss it if we are ok with having three sergeants.

Mayor Hutnick asked what is the harm in have three sergeants.

Councilman Ciasullo commented there is no harm it is just the fact you have to discuss it because [what if] a year from now we have three sergeants and nobody retires.

Councilwoman Ruitenber commented it is not on a permanent bases it is on a temporary bases until somebody retires.

Sgt. Sanfilippo commented he is very concerned if you don't do it you are not going to have a sergeant for some time.

Councilwoman Ruitenber commented why wouldn't we. She just called for the certification list that is only good for three months because she called for it; the eligibility list was good until next year some time.

Sgt. Sanfilippo commented understood but these guys are graduating in November.

Councilman Ciasullo asked Sgt. Sanfilippo they graduate in November; your thought is a sergeant should train them.

Sgt. Sanfilippo commented regardless of when either list expires; if he is going to be training these guys he should be promoted this year. Being he is training them and he has done that work from December until August. That isn't very fair honestly. He doesn't have to take on that responsibility.

Ms. Hough explained there is the certification that is good until November 29, 2024 and there is the eligibility roster that is good until 10-19-2025. The certification has to be coded in three months.

Councilwoman Ruitenber commented yes because you called for this list. So, we would need to do something with that either going forward with it or not going forward with it. But he would still remain on the list if we choose not to do it right now.

Ms. Hough explained the only thing is you know civil service; when we [called] for a list for police officer and we didn't hire anyone on that list. You know Civil Service frowns on that. Councilwoman Ruitenber commented right.

Ms. Hough commented she had to explain to civil service why nobody was hired off that list.

Sgt. Sanfilippo asked can you make him an acting sergeant with the benefits and the stripes and pay upon until the other sergeant actually retires. Is that an option?

The discussion continued on having three sergeants, acting sergeant, time frames, being acting and then not getting the position, PBA is willing and agrees to three sergeants temporarily and having the promotion before the new officers graduate the academy,

Mr. Maddaloni explained the first thing he thinks you need to focus on is whether you are going to make the third sergeant position. That should be done without reference to the individual that would fill that position. That is the first step; PBA has agreed to again with the extent that the table of organization is a negotiated item in the PBA contract and he can't tell you if it is until he sees the contract. Apparently, they believe it is and believe they have some input in it and that is why they gave a waiver. So, they are agreeing to the third position on a temporary bases so excepting that as being valid and as being necessary because they have a say in it they [PBA] have given you the green light to create the third position on a temporary basis. So, obviously there is a cost associated with it that is why you have your numbers [person here CFO] to give you the information needed in relation to that. But then the issue becomes moving forward and creating the position.

Councilman Ciasullo asked how is it stated as a temporary position; how is it written in there.

Mr. Maddaloni read for the record with a title of Addendum B:

“Effective immediately, the Ogdensburg, Unit PBA Local #404 and the Borough of Ogdensburg agree to temporarily create a third (3rd) position for sergeant. This position shall remain effective

until the retirement or promotion of one of the current sergeants, at which time the police department will revert to maintaining two (2) positions for sergeant as per the current agreement.”

Sgt. Sanfilippo commented when that sergeant retires and this sergeant gets promoted we are going to have one sergeant for a minimum of three years.

Councilman Ciasullo asked Mike Marceau his end of it [regarding the budget].

Mr. Marceau explained it's ok you are only talking a couple of months.

Councilman Ciasullo asked Sgt. Sanfilippo your thought was right before they get out [of the academy] that way they get introduced to a sergeant and get used to his training.

Sgt. Sanfilippo explained he isn't going to be much use or available because he will be training himself to learn the Chief's job; he is going to help those guys the best he can and assist Officer Cowdrick.

Councilwoman Ruitenberg asked who trained the two of you [Sgt. Sanfilippo and Ptl. Cowdrick].

Sgt. Sanfilippo commented [Chief] Gordon.

Councilman Ruitenberg commented she is just asking; there is nobody else that is available to train.

Sgt. Sanfilippo explained we never had an FTO program; [Officer Cowdrick] he has been through it that is number one; number two we have never had 70% of the department retiring within the same week. What are our options here? At least give the guy an opportunity to learn that position and train the new guys.

Councilman Ciasullo commented he will make the motion we can still discuss it.

Mayor Hutnick asked what is there to discuss?

Councilman Ciasullo commented he will make a motion to [enact] addendum B.

Mr. Maddaloni commented the motion would be to accept addendum B proposed by the PBA allowing for a third sergeant position to be temporary created in the police department.

Councilman Ciasullo asked do we put a date on that or after we do the motion.

Mr. Maddaloni commented it would be if the motion is approved obviously it would be effective immediately and the temporary nature of it is built into the addendum which is it ends whenever another sergeant retires and then the table of organization reverts back to the two current positions. Presumably there are plans in place for people to move around so you probably have an idea as to when the table will revert back based upon the retirement papers that have been submitted. The addendum itself says whenever the next police sergeant retires. If you want we can draft a more detailed resolution that includes a date but he thinks you are protected because this is identified as a temporary position and it ends on the date of one of the three sergeants you have retirees and you are left with the two positions.

Ms. Hough asked the motion is to accept addendum B allowing for the third sergeant until the time when one retires.

Mr. Maddaloni commented correct; to allow for the temporary creation of the third sergeant position.

Sgt. Sanfilippo asked does that include making the actual promotion as well.

Councilwoman Ruitenber commented no.

Mr. Maddaloni commented that is the second motion first you have to create the position.

Mayor Hutnick commented take the verbiage off the contract.

Mr. Marceau commented in theory it is a management right and it is not negotiable let's just say we do this and it becomes negotiable in the future or should this be something that we spell out simplicity.

Mr. Maddaloni commented he doesn't know what the PBA contract says.

Mr. Marceau commented shouldn't we look at that first.

Mr. Maddaloni commented he is presuming as to what has been provided here by the PBA that they have a bases of what to include that the table of organization is specified in the contract. If you want to take a break he will take a look at the contract.

At this time Mr. Maddaloni reviewed that contract.

Councilman Ciasullo asked what are we looking for.

Mr. Marceau explained if the organization chart isn't specifically mentioned in the contract and then we add it in via the addendum; then it becomes negotiable in the future vs right now it is our prerogative.

There was a discussion on the contract and the retirements while Mr. Maddaloni reviewed the contract.

Mr. Maddaloni commented the only reference he sees [in the contract regarding a table of organization] is in the salary guide. It references two sergeants shall receive an additional five thousand when promoted to sergeant. There is nothing else in the contract that addresses the table of organization per say nor the borough in it right to establish in its sole discretion a table of organization.

Mr. Maddaloni explained a table of organization is generally not a negotiable item. You can waive that right by putting that in their contract but once you do that you are stuck with that table of organization in negotiations. The other things here is the salary reference two sergeants, there is no table of organization there is no reservation of management rights clause. The bottom line is you don't have the table of organization in the ordinance either. The numbers that you want to hire is at your discretion whether the PBA has to approve it or not. So, they told you they will consent to adding the third sergeant that is assuming they need the consent. If they need the consent they have done that and they have also indicated that it will revert back to two positions when one of the three retires. Mr. Maddaloni explained your options are do you want to fight that battle with the PBA now you can still add the third position and do it on the same terms they have offered you; that is do it on a temporary bases with the provision the third position will expire once one of the three sergeants retires in the future without any reference to the PBA waiver at all. You still have the right to do that and given this issue he would advise you handle it in that manner rather than acknowledging perhaps incorrectly that there is [anything] to discuss with the PBA to discuss or negotiate to control the table of organization.

Ms. Hough asked there is a motion on the table and there was never a second.

Mr. Maddaloni commented they might want to amend the motion.

Mr. Maddaloni explained the only thing you would modify is that your motion is without regard to whether the PBA has agreed or consented or offer a waiver because frankly you are not prepared to recognize that as necessary.

There was back and forth as to what the motion should be.

Councilwoman Ruitenberg commented the motion would be to create temporarily a sergeant position in the police department until one of the existing three sergeant retires.

Ms. Hough asked the motion is to create a temporary sergeant position in the police department until one of the three sergeants retire or is promoted. Mayor Hutnick continued with “at this time the police department will revert to maintaining two positions for sergeants.

Ms. Hough asked who is making this motion.

Councilman Ciasullo made the motion. Seconded by Councilwoman Ruitenberg.

Sgt. Sanfilippo commented now would be better he has to learn the sergeant position.

Councilwoman Ruitenberg asked Mr. Marceau how does this coincide with payroll and pensions.

Mr. Marceau commented he will figure it out.

Councilwoman Ruitenberg asked would the middle of the month or end of the month be better. When is the next pay period?

Mr. Marceau commented we just got paid on Friday.

Councilwoman Ruitenberg commented so today is the first day of the pay period going forward.

Mayor Hutnick commented make it effective today.

Councilwoman Ruitenberg commented you can't make it effective today it's done and over with.

Councilwoman Ruitenberg commented effective tomorrow September 10, 2024 appointing David Cowdrick to sergeant effective September 10, 2024. Mr. Maddaloni added and to authorize the borough clerk to take any action with civil service.
