**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF THE CODE
OF THE BOROUGH OF OGDENSBURG ENTITLED "TRAFFIC" SECTION 7-10.
TEMPORARY PARKING PROHIBITION FOR SNOW PLOWING AND REMOVAL**

WHEREAS, the Borough of Ogdensburg ("Borough") desires to amend and supplement Chapter 7 Traffic Section 7-10 Temporary Parking Prohibition for Snow Plowing and Removal to add section 7-10.2 violations.

NOW THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 7 Section 7-10 Temporary Parking Prohibition for Snow Plowing and Removal of the Borough Code is hereby amended, revised and supplemented by adding Section 7-10.2 violations as follows:

SECTION 1.

Chapter 7 Traffic

§ 7-10.2 Violations


Any person (s) who is found to be in violation of this section shall be subject to a fine of \$100.00 for each violation.

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith are repealed.


SECTION 3. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall become effective after second reading and publication as required by law.




