ORDINANCE 06-2025**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 OF
THE CODE OF THE BOROUGH OF OGDENSBURG ENTITLED
"TRAFFIC" TO PROHIBIT PARKING ON OR ALONG A PORTION OF
EDISON AVENUE (EAST SIDE)**

WHEREAS, the Borough of Ogdensburg ("Borough") desires to amend and supplement Chapter 7, Section 7-14 of the Borough Code entitled "Parking Prohibited at All Times on Certain Streets" to prohibit parking on or along the east side of Edison Avenue in front of the access gate to Hemlock Island.

NOW THEREFORE, be it ordained, by the Mayor and Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 7, Section 7-14 of the Borough Code is hereby amended, revised, and supplemented as follows:

SECTION 1.

The following street, side, and location shall be added to the list of streets set forth in Section 7-14 where parking is prohibited at all times:

Chapter 7 Traffic

§ 7-14 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS

No Person Shall Park a Vehicle at anytime upon any street or parts thereof described.

Name of Street	Side	Location
Edison Avenue	East	In front of access gate to Hemlock Island


SECTION 2. All other provisions unaffected by this Ordinance shall remain in full force and effect.


SECTION 3. All Ordinances or parts of Ordinances inconsistent herewith are repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall become effective after second reading and publication as required by law.




